- No power is available unless previously arranged.
- Cost of camping on the grounds is not included.
- **No vehicles are allowed at vendor spaces** with the exception of unloading on Friday for setup and loading on Sunday during teardown after show. Parking is available on the grounds in day parking.
- No vendors are allowed to sell hats, t-shirts, or sweatshirts.
